CONSENT AGENDA:

DEPARTMENT HEAD REPORTS:

Police Chief Schultz presented his report. They experienced medium number of calls last month. The new officer will be attending academy in September. Councilperson Kipp moved to accept the Police Chief's report and Councilperson Nelson seconded the motion. Motion carried 4-0.

CORRESPONDENCE: None

WORK SESSION: Tony Sitzmann addressed the Council in regards to a business he is trying to get off the ground. The business is a dog food plant that he would like to have located on airport property. Mr. Sitzmann's hope is that the City/County will donate the land for his business. He asked if the Council will be in favor of such a business and was told that his first step should be to present to the Airport Authority since they have governance over the airport. The plant would need between 100 and 300 acres of land and would incluse a slaughterhouse for cattle, swine and poultry; as well as a settling pond and a refuse pile. The downside of such a business is the odor of the livestock and compost pile. The business would need to be completely fenced to keep out bears. Mr. Sitzmann thanked the Council for their consideration.

COMMITTEE REPORTS: Councilperson Kipp reported that the Chamber has been busy. Their Annual Banquet will be held on April 18, 2020, at the Civic Center. They are looking for Chamber Up hosts.

Councilperson Curtiss reported that the Tri-City Interlocal audit was completed last week and the bookkeeping and Head Superintendent duties have now been transferred to Conrad.
